The Information on 2021 Mini Gems Emporium

1. The significant 2021 Mini Gems Emporium, under the supervision of the Ministry of Natural Resources and Environmental Conservation, will be held on December 17 to 22 , 2021 at Maniradana Jade Hall in Nay Pyi Taw.
2. Myanmar Pearl lots will be sold in US Dollars (USD) and Rough Jade lots will be sold in Euro currency at the Emporium. Payment for jade lots shall be made in Euro or US Dollars (USD).
3. Pearl lots and jade lots will be put up for sale through open tender system and specifying reserve prices as follows;

Sr.	Kind of Gem	Reserve Price
(a)	Pearl	US\$ 1,000 and above
(b)	Jade	€ 5,000 and above

4. Foreign visitors who are eligible for the following qualifications will be granted admission to the 2021 Mini Gems Emporium , excluding those blacklisted for their default on payment in the previous emporiums;
 - (a) The person who requested the invitation card via the local representative companies.
 - (b) The person who requested the invitation card via the Foreign Jade Associations.
 - (c) The person who requested to receive the invitation card through the respective Embassies and Consulate - General.
5. Merchants will be allowed to make bids for the jade lots only upon the completion of paying the amount of minimum deposit (€ 20,000) to bid for jade lots up to the value of € 200,000.
6. In case of preferring to make bids more than the minimum deposited amount, buyer shall deposit the 10% of value of the lots intended to bid for by the type of lots concerned on or before December 19, 2021.

7. Starting from December 10, 2021, entrance card will be issued at the Maniradana Jade Hall, Registration Office and the designated Hotels to the foreign merchants who have already paid the deposit ahead.

8. Application Forms for admission to Emporium can be downloaded from provided website www.mge.gov.mm , starting from December 10, 2021. Application can also be submitted via On-Line Pre-Registration System from Myanma Gems Enterprise website www.mge.gov.mm .

9. The requirements to make the entrance card are as follow;

- (a) Name, Passport and National Scrutiny Card No. (Passport Issuing Country)
- (b) Clear Photocopy of Passport
- (c) Clear two passport photos taken within one month
- (d) Complete contact information, (to state Phone No., Fax No., E-mail and address)
- (e) Admission fee – US\$ 100 .
- (f) Foreign Merchants must arrive in Myanmar before December 13, 2021.
- (g) Only Merchants who stay at Zabu Thiri Hotel , Mingalar Thiri Hotel and Man Myanmar Hotel during Emporium period will be allowed to get entrance card.
- (h) Every Merchant must submit the Certificate of fully vaccination.
- (I) All Merchants will be tested for Covid-19 by RT-PCR and also will be subjected to 3-day hotel quarantine designated by the Ministry of Health on their arrival in Myanmar. The Medical cost and accommodation fee will be borne by oneself.
- (j) Merchants who have already arrived in Myanmar must submit the date of departure from the origin airport before boarding to any airline destined for Myanmar, their vaccination certificate and health declaration card approved by the Ministry of Health after their quarantine period.

10. Jade lots can be checked from provided website www.mge.gov.mm. If buyer himself cannot attend the Emporium, his authorized representative person will be allowed to inspect and purchase the Lots according to the terms and conditions.

11. Buyers themselves or their authorized representative person shall settle payment for the purchases within deadline as prescribed by the Sales Agreement.

12. Shipment of fully paid purchase to the buyer is made under the EXW(EX Works)System. Purchase will be timely dispatched once the buyer himself or his authorized representative person has made full payment for the purchase. Emporium Central Committee will be responsible for loading the merchandise onto the Transportation Vehicles from the Emporium Hall while the buyer himself or his authorized representative company will be held liable for the remaining processes.
